A RESOLUTION TO APPROVE DISBURSEMENT OF FUNDS FOR THE AMERICAN RESCUE PLAN ACT

WHEREAS, on March 11, 2021, President Biden signed the 109 trillion-dollar American Rescue Plan Act and,

WHEREAS, Worth County applied for and has been received the funds for the American Rescue Plan Act totaling \$1,433,673.

WHERAS, the Worth County Board of Supervisors has reviewed some requests and determined some that will qualify for the American Rescue Plan Act and

WHEREAS, based on the distribution guidelines from the US Department of Treasury, the following projects have been approved for the use of said funds:

- Additional \$19,000 in funds to complete Water & Wastewater improvements at the 1-35/Hwy 105 interchange (Total Project \$719,000).
- Final Payment for Recorder's Scanning Project in the amount of \$9,625.
- Capital Repairs/Improvements to County Buildings/Property in the amount of \$61,548.

BE IT RESOLVED that the Worth County Board of Supervisors endorses the disbursement of American Rescue Plan Act Funds for the items listed and authorizes the Auditor to make these payments as they are presented.
