- 5. All the boards are in at both Mehus and Wood Duck Hollow. Not sure if the seeding of emergent plants worked or not.
- 6. We have sprayed the weeds at the Prestholt/Frahm addition in preparation of a dormant seeding. The contractor for the dirt work has not come back yet.
- 7. The new hay field at Panicum has been seeded. The field at Wally's Woods will be dormant seeded do to the hot dry weather.
- 8. The cap stone for the bridge approach at Worth County Lake has been put on.
- 9. The van for the intern has been sold back to the Trading Post.
- 10. We are almost sold out of trees for the Alliant ReLeaf program.
