## RESOLUTION SETTING NEW DATES FOR BID LETTING

WHEREAS, the Board of Supervisors of Worth County, Iowa has determined that it is necessary to set new dates for the receipt, opening and consideration of bids for the proposed **Conservation Facility Remodel Project** (the "Project"), and to advertise for sealed bids for the Project;

NOW, THEREFORE, Be it Resolved by the Board of Supervisors, Worth County, Iowa, as follows:

Section 1. The Board of Supervisors hereby delegates to the Auditor and / or Veenstra & Kimm, Inc. (the "Project Engineers") the duty of receiving bids for the construction of the Project before 11:00 a.m. on January 21, 2025, at the Board Chambers, Worth County Court House, Northwood, Iowa. At such time and in such place, the Board of Supervisors hereby delegates to the County Auditor and/or Project Engineers the duty of opening and announcing the results of the bids received. January 27, 2025, at 8:30 a.m. is hereby fixed as the time and place that the Board of Supervisors will consider the bids received by the Auditor in connection therewith.

Section 2. The amount of the bid security to accompany each bid is hereby fixed at 5%.

Section 3. The Auditor is hereby authorized and directed to post Notice to Bidders at least once in a relevant contractor plan room service with statewide circulation, and in a relevant construction lead generating service with statewide circulation, and on an internet-site sponsored by either the County or statewide association that represents the County. Posting shall not be less than thirteen clear days nor more than forty-five days prior to January 21, 2025, which is hereby fixed as the date for receiving bids. Said bids are to be filed prior to 11:00 a.m. on said date; and,

Section 4. All provisions set out in the attached form of notice are hereby recognized and prescribed by the Board of Supervisors and all resolutions or orders or parts thereof, to the extent same may be in conflict herewith, are hereby repealed.
