5. Proposed Budget Amendment FY 2026 - Salaries

Assessor Thompson proposed to the Conference Board that the office move from 35 hours/week to 40/hours per week. She proposed a salary increase for the Assessor from \$78,595 to \$86,000 annually and for the Chief Deputy Assessor from \$62,751 to \$69,720 annually to compensate for the increase in hours worked.

After some discussion, Pulju motioned and Severson seconded to approve the proposed budget amendment for publication.

6. Proposed Budget Amendment FY 2026 - Transfer of Funds

The budget amendment proposed on September 10, 2025, failed to meet state publication requirements. It will be published again. This amendment proposes that \$35,000 be moved from the Assessor Reserve fund into the FY 2026 budget for vehicle expenses, and \$30,000 be moved from the Assessor Reserve fund into the FY 2026 budget for legal expenses.

A public hearing is scheduled for December 10, 2025, at 6:00 p.m. at the Worth County Courthouse in Northwood, Iowa.

The Board met to review the proposed budget amendment for the Worth County Assessor's Office for FY 2026.
