Resident hunters age 15 or younger may hunt rooster (male) pheasants during the Youth Pheasant Season without having a Hunting License, paying the Habitat Fee, or passing a hunter education course. The youth hunter must be accompanied by an adult 18 years old or older who has a valid Hunting License and has paid the Habitat Fee if normally required to do so to hunt. Only the youth may shoot pheasant.
